1. The Government of Tanzania has set aside funds for the operation of the Busokelo District Council during the financial year 2017/2018. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for construction of Water Projects.
2. The Busokelo District Council now invites sealed eligible civil contractors registered in or capable of being registered in *class Five (5) or above for Kanyebele and in class six (6) or above for Mpata* as per respective requirement as follows:-

Box 02, TUKUYU** at or before 11:00 am on Thursday 30<sup>th</sup> August, 2018. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening ceremony at the Council Hall
8. The Bidder at his own cost is to make site visit for the package he is interested or all packages. The site visit is scheduled to be conducted on **24<sup>th</sup> August, 2018** and all Tenderers shall meet at District Water Engineer's Office at 10.00 am
